

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

The Legislative Defendants' highly visible 14th Amendment,  
very first section, very first 28-word sentence  
propagates misdirection with the precision of a GPS-guided multi-warhead missile  
targeting intellect every minute of every day, year after year.

This sentence's first strike on OUR Constitution:

*“All persons born or naturalized in the United States,  
and subject to the jurisdiction thereof,  
  
are citizens of the United States  
  
and  
of the state wherein they reside.”*

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

By Constitutional mandate (non-expansion, Art I, Sec 8, Cl 18; 10<sup>th</sup> Amend)

and the Legislative Defendants' Sworn Obligation,

any **Amending** must **clarify** while **adhering to pre-established limits**.

The Legislative Defendants' subject matter assignment (Art I, Sec. 8)

**clearly DOES NOT include any authority**

**to alter** ANY ***“persons born or naturalized in the United States”***.

The Legislative Defendants have unconstitutionally CHANGED

***“All persons*** *born or naturalized in the United States”*.

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

The word “**ARE**” specifies unauthorized **ALTERATION**

of “*Unalienable Sovereign*” Americans;

thereby a documented continual Breach of Authority.

The word “**AND**” fabricates a **2nd CLASS of AMERICANS**;

thereby another documented continual Breach of Authority

Both are self-evident Subversions of OUR Constitution.

(OUR Const, Art I, Sec 8, Cl 1-17)

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

Pre-existing references in OUR Fundamental LAWS

to “*person*”, “*people*”, or “*citizen*”

relay concise meaning; thereby specifying only TWO categories,

**Unalienable Sovereign Citizens** (through birth or naturalization)

**And**

**foreigners residing anywhere in America:**

## Legislative Subversion of Sovereignty (Sec 1, sentence 1)

*“WHEN in the Course of human Events, it becomes necessary for one People to dissolve the Political Bands which have connected them with another, and to assume among the Powers of the Earth, the separate and equal Station to which the Laws of Nature and of Nature's God entitle them, a decent Respect to the Opinions of Mankind requires that they should declare the causes which impel them to the Separation.”*

*“WE hold these Truths to be self-evident, that ALL MEN are created equal ... that they are endowed by their Creator with certain unalienable Rights ...”*

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

*“We the People of the United States,*

*in Order to ... secure the Blessings of Liberty to ourselves and our Posterity ...”*

*“The judicial Power shall extend to all Cases, in Law and Equity, arising under this Constitution, the Laws of the United States, and Treaties ...;*

*--to Controversies between two or more States;*

*--between a State and Citizens of another State;*

*--between Citizens of different States,*

*--between Citizens of the same State claiming Lands under Grants of different States,*

*and between a State, or the Citizens thereof, and foreign States, Citizens or Subjects. “*

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

*“The Citizens of each State*

*shall be entitled to all Privileges and Immunities*

*of Citizens in the several States”.*

OUR Const. Art. IV, Sec 2, Cl. 1

*“No person except a natural born citizen, or a citizen ON the United States,*

*at the time of the adoption of this Constitution,*

*shall be eligible to the office of President: ...”*

# Legislative Subversion of Sovereignty (Sec 1, sentence 1)

**Eligibility for Presidency is the only exception** in OUR Constitution

where a naturalized foreigner does not have the same STATUS  
as a natural born American.

The ONLY other class is non-American (i.e., foreigner, alien).

OUR **ONE CLASS** of “*We, the People*”

is SOVEREIGN AMERICAN CITIZEN,

an **Unalienable** Birth **RIGHT** or Naturalized **RIGHT**,

established **pre-Government**.
