- **SEIZURE OF YOUR BANK ACCOUNT, YOUR WAGES AND YOUR REAL ESTATE**
- **FILING OF A STATE TAX LIEN WHICH BECOMES PUBLIC RECORD**

You can avoid these possible **ENFORCEMENT** actions by enrolling in a written, authorized installment program by calling our office at (877) 421-1133, or by mailing your **FULL** payment with the attached payment coupon in the enclosed envelope. Make your check/money order payable to COMM OF MASS.

If you have an abatement pending with the Department of Revenue or an appeal filed with the Appellate Tax Board you are temporarily not required to pay the disputed amount until your case is resolved. Taxpayers with this type of appeal will be withdrawn from the agency.
