

## Legislative Subversion of Voting (Sec 2)

The **14<sup>th</sup> Amend, Sec 2** is

incongruous with "*Morality and Reason*",

non-allegiant to OUR Republic's unique Societal Structure,

and repugnant to OUR Constitution.

**Sentence 1** allows any non-Americans

(i.e., visiting diplomats, foreign tourists, illegal immigrants, terrorists, etc.)

to be represented in elections:

**"Representatives shall be apportioned** among the several states according to

*their respective numbers, counting the whole number of persons in each state"*

## Legislative Subversion of Voting (Sec 2)

(a) OUR Const, Art I, Sec 2, Cl 2 below specifies

**a Representative of "We, the People" must be a Citizen;**

hence the essence of the assignment - "**Representative**";

thereby disgraceful that a "**Representative**"

would represent anyone other than "*citizens*":

*"No Person shall be **a Representative** who shall not have attained to the Age of twenty five Years, and been seven Years **a Citizen of the United States**, and who shall not, when elected, be **an Inhabitant of that State** in which he shall be chosen."*

OUR Const, Art I, Sec 2, Cl 2

## Legislative Subversion of Voting (Sec 2)

(b) In OUR Const, Art I, Sec 2, Cl 3 below, "free Persons" denotes "citizens";  
affirmed in OUR Declaration and OUR Constitution's Preamble  
as "We, the People",  
the originators of all Government positions, including "Representatives":

*"Representatives and direct Taxes shall be apportioned among the several States which may be included within this Union, according to their respective Numbers, which shall be determined by adding to the whole Number of free Persons, including those bound to Service for a Term of Years, ... The actual Enumeration shall be made within three Years after the first Meeting of the Congress of the United States, and within every subsequent Term of ten Years, ..."*

## Legislative Subversion of Voting (Sec 2)

(c) The Legislative Defendants' sentence above suborns the unconstitutional counting of ALL persons in each State as well as government employees in the District of Columbia and other federal "places";

thereby harvesting Misrepresentatives instead of Representatives.

## Legislative Subversion of Voting (Sec 2)

The **14<sup>th</sup> Amend, Sec 2, sentence 2** below escalates subversive misdirection by including "**ANY INHABITANTS**"

with their previous Section 1 subversion of "*citizens of the United States*":

*“But **when the right to vote** at any election for the choice of electors for President and Vice President of the United States, Representatives in Congress, the executive and judicial officers of a state, or the members of the legislature thereof, **is denied to any** of the male **inhabitants of such state**, being twenty-one years of age, **and citizens of the United States, or in any way abridged**, except for participation in rebellion, or other crime, the basis of representation therein shall be reduced in the proportion which the number of such male citizens shall bear to the whole number of male citizens twenty-one years of age in such state.”*

## Legislative Subversion of Voting (Sec 2)

(a) Above, the Legislative Defendants exert unconstitutional authority by subversively proffering a non-existent Right.

INHABITANTS includes NON-Americans;

they DO NOT HAVE "the right to vote" (8 USC 14XX).

There is no "*denial*" or "*abridgement*" of a non-existent Right:

"when the right to vote ... is denied to any ... inhabitants of such state"

## Legislative Subversion of Voting (Sec 2)

The above sentence, camouflaged with Constitutionally accurate fragments, suborns illegal voting (18 USC 611) of **non-American inhabitants** of OUR States.

Together with their previously detailed

unconstitutional "**citizens of the United States**",

these misdirections dilute the votes of all Americans and suborn

collection of false Census data from States and federal territories

(i.e., District of Columbia, Guam, etc. - ref 23<sup>rd</sup> Amend);

thereby harvesting illegal Misrepresentatives instead of Representatives;

thereby subverting OUR Election process and threatening OUR Societal Structure.
