### *Why did I receive this notice?*

Our records indicate that you, DAVID FONTAINE, have an outstanding Personal Income Tax liability of \$3,070.00 and may benefit from participating in the Massachusetts Department of Revenue (DOR) 2024 Tax Amnesty Program ("Tax Amnesty 2024") that was recently established for certain taxpayers. This letter is only for Personal Income Tax. If you have other eligible tax liabilities, you will receive a separate letter.

### *What should I do?*

You must submit an Amnesty Request on MassTaxConnect and pay all the tax and interest due **during the amnesty period** (November 1 through December 30, 2024). If the request is submitted and the full amount is paid by **December 30, 2024**, DOR will waive the penalties identified as "Amnesty Savings" in this notice. Please note interest continues to accrue until the full tax balance is paid.

Do not mail back this letter with your payment. You must first submit the Amnesty Request electronically on MassTaxConnect to be eligible. You will have an opportunity to make your payment when you submit the online request.

Please note, payments made prior to the date of the notice may not be reflected in the amounts listed below and may impact your eligibility for Tax Amnesty 2024.

Collection actions will continue on your account, including the authority to lien and levy assets and suspend licenses. If you are currently in a payment agreement, you must continue to comply with the terms of the agreement.
